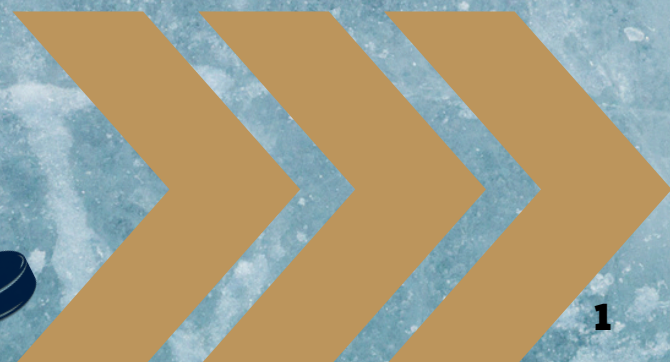

Topics will include foundational system management, backup and preservation of user settings and dictionaries, translation optimization tools such as Auto-Brief and Translation Magic, realtime and captioning setup, dictionary organization strategies, audio management techniques, and workflow-enhancing features including Boost, Boost Flow, Boost Edit, and commonly used Eclipse plugins. Through practical, real-world applications, attendees will gain strategies to improve consistency, reduce cleanup time, and strengthen overall reporting workflow efficiency across a variety of reporting environments.

The session will also cover powerful dictionary management features in Case CATalyst, including filter commands, high-frequency word analysis, briefing strategies, and Autoinclude tools to strengthen translation accuracy.

Additional topics include useful realtime commands for on-the-fly text cleanup, number conversion, capitalization shortcuts, untranslated steno assistance, and live suggestion features. Participants will also gain insight into Stenograph technical support resources, including best practices for obtaining assistance and navigating the online Solution Center. The session concludes with editing techniques designed for fast-paced proceedings and difficult audio, highlighting efficient text insertion methods such as EZ-Text, personal globals, and speaker lists, along with strategies for quickly correcting transcript text during editing.

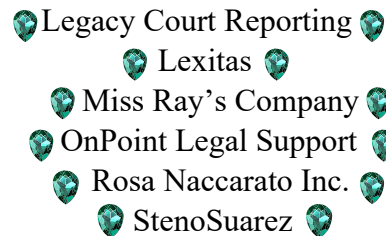

What Every Court Reporter Needs to Know About CLVS Standards

Speaker: Joel Freedman, CLVS

You have almost certainly worked alongside a legal videographer. You may have watched one set up lights, adjust microphones, and stare intently at a monitor while you quietly wondered what, exactly, they were doing over there and whether any of it had anything to do with you. The answer, it turns out, is yes — quite a lot of it, actually. The NCRA's CLVS standards govern everything from how many microphones must be in the room to what happens when counsel can't agree on going off the record, and a surprising number of those standards have direct implications for your transcript, your record, and your ability to do your job well. This session exists because most likely nobody told you any of this, and it seemed like time someone did. Over 90 minutes, CLVS certified videographer Joel Freedman will walk you through the standards that matter most — not as a recitation of rules, but as a practical guide to what you should be watching for, what you're entitled to ask for, and how a great working relationship with your videographer makes both records stronger. You'll leave knowing why the videographer is fiddling with the lights, what to do when audio goes sideways, how on- and off-the-record transitions are supposed to work for both of you, and more. It will be useful. It will be entertaining. And unlike a considerable number of professional development sessions, it will not make you wish you had chosen the one about software updates instead.
